Background: Manifesto for a Renaissance in Economics

In light of global crises and growing socio-environmental challenges, the limitations of traditional economic paradigms have become increasingly apparent The Manifesto for a Renaissance in Economics *(attached below and signed by more than 350 Italian academics)* advocates for a new economic paradigm going beyond reductionist approaches in five directions, which also constitute the pillars of the Manifesto:

i) human beings are more than *homines economici*, have also other-regarding preferences and are capable of cooperative equilibria in social dilemmas;

ii) companies and organizations do not have profit maximization as unique goal but can also have a taste for social and environmental impact;

iii) wellbeing is more than GDP and requires multidimensional wellbeing indicators and macroeconomic analysis where interdependences between creation of economic value and social and environmental domains are taken into account;

iv) political economy is not just top down but includes the lever of participation and active citizenship in different forms;

v) civic engagement of academicians is important in times in which vigilance and action to solve global crises are of utmost importance and we risk a broadening gap between scientific advances and the average culture and education of the overall population.

The conference will primary focus on:

- 1. **Presentation and Discussion of the Manifesto** A session dedicated to introducing and examining the key principles outlined in the Manifesto.
- 2. **Keynote Addresses by Renowned Scholars** Talks by leading invited experts on the foundational pillars of the Manifesto.
- 3. **Research Paper Sessions** Presentations of selected research papers that contribute to the themes and pillars outlined in the Manifesto.
- 4. **Assembly of Manifesto Co-Signers** A gathering of signatories to discuss shared commitments and future initiatives.
- 5. **Discussion on the International Declaration** An in-depth conversation focused on crafting an international declaration inspired by the Manifesto's values.
- 6. **Dialogue with Students and Youth on the Manifesto** An open forum for younger generations to engage and debate the principles of the Manifesto.

Call for paper

This conference explores a transformative shift in economic thought, moving beyond reductionist approaches that focus solely on profit maximization, GDP growth, and self-interested agents. By embracing a more holistic and integrated perspective, we can build economic models that better align with human values, social wellbeing, and environmental sustainability.

Research Focus Areas:

- **Beyond Homo Oeconomicus**: We invite theoretical and empirical contributions that investigate individual preferences, empathy, emotional factors, caring systems, education, welfare structures, and cooperative solutions to social dilemmas. Submissions from fields such as behavioral, feminist, comparative economics, environmental and ecological economics are welcome. Submissions should explore how these insights can reshape microeconomic foundations and macroeconomic frameworks, aiming to address social and environmental challenges through improved policy design.
- **Beyond Profit Maximization**: Papers are welcome that examine alternative goals for companies and organizations, such as the pursuit of social and environmental impacts, gender equity, and value-driven economic contributions, moving beyond traditional profit-focused models.
- **Beyond GDP**: Contributions to the study of multidimensional societal wellbeing are encouraged, particularly those that consider the intersections of social and environmental factors, capability development, complex systems, sustainable development, and the relative influence of income and non-income factors on life satisfaction and meaning.
- **Beyond Top-Down Political Economy**: We seek theoretical and empirical work on grassroots initiatives, local community actions, collaborative welfare strategies with public and private entities, subsidiarity in governance, and multi-level policy making to explore the transformative potential of participatory political economy.
- **Toward Civic Engagement:** We welcome studies on the civic role of academics, including the societal impacts of their work and the significance of academic involvement in addressing global issues.

Purpose and Outcomes

This conference aims to facilitate interdisciplinary dialogue among economists, social scientists, policymakers, business leaders, and civil society advocates. By examining these five core directions, participants will explore how economic models and policies can be redesigned to promote a just and sustainable global future. Attendees will gain insights into innovative approaches and collaborate to formulate actionable recommendations that bridge theory and practice.

Who Should Attend

This conference is open to researchers, academics, policy advisors, business leaders, non-profit organizations, and any individuals interested in advancing an economic paradigm shift toward sustainability, equity, and resilience. Expected conference participants are both senior and young. This conference seeks bold and innovative perspectives that challenge traditional approaches to economics, embracing more comprehensive, sustainable, and people-centered models.

We encourage submissions that reflect on key themes within our Manifesto and contribute to building a holistic economic framework for a sustainable future.



Contributions on New Economic Paradigm

Participants may contribute in the following ways:

- 1. **Full Research Papers**. Submit a complete paper presenting new findings or theoretical contributions related to the conference themes. Papers may focus on advanced topics or deep analyses that explore the potential for transformative change in economic paradigms.
- 2. **Extended Abstracts for Presentations.** Submit an extended abstract (600-1,000 words) summarizing the main arguments, research questions, and key insights of your research or practice-based work.
- 3. **Policy or Practice-Oriented Contributions.** For those with expertise in policymaking, consulting, or applied research, we welcome policy papers or case studies that demonstrate real-world applications and impacts related to the conference themes. Submissions should provide in-depth analysis, insights, and lessons that inform best practices or actionable recommendations.

Themes for Submissions

Submissions should align with one or more of the **Research Focus Areas**. Although not exclusively, submissions should mainly refer to the five pillars.

Formatting Guidelines

- **Full Papers** should be 3,000–8,000 words in length, with standard academic formatting (e.g., Times New Roman, 12-point font, double-spaced).
- **Extended Abstracts** should be between 600 and 1,000 words, outlining the core research questions, methods, and insights.
- **Policy Papers/Case Studies** should include an executive summary and total between 1,500 and 5,000 words.

Submission Process

- Submit documents in PDF or Word format by **February 9th**.
- Each submission should include the author's name, affiliation, and contact information.
